102.5 JACK-FM'S "Cirque du Soleil" CONTEST OFFICIAL RULES

Eligibility. All entries must be received by 11:59pm CT on November 17, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider
- 4. Winner Selection. On or about 9:00am CT on November 18, 2024, Station will select three (3) potential Prize Winner(s) in a random drawing from among all valid entries received by Station during the Contest Period.
