102.5 JACK-FM's "THE SMITHEREENS TEXT-TO-WIN" CONTEST OFFICIAL RULES

Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider
- 4. Winner Selection.
